Commercial Loan for Energy Efficiency and Renewable Program (CLEER) is a loan program offered by the Montgomery County Green Bank through its Participating Lenders to provide financing solutions for clean energy projects in Montgomery County, Maryland. The Montgomery County Green Bank set up the program to bring flexible financing options for the clean energy projects of your building/business.

CLEER Offers:

- 100% financing no-out-of-pockets
- No additional debt on property (based on credit)
- Loan terms up to 12 years to help match energy cost savings to loan payments
- Covers: energy efficiency, solar PV, energy storage, gas furnaces and boiler, combined heat and power
- 30% of loan can cover non-energy efficiency improvements (e.g., water conservation, EV charging stations)
- 50% of utility rebates that get paid after installation can be included in the loan

CLEER Ways to Finance

CLEER financing is available to our Authorized Contractors through our Participating Lenders who can find a loan that works for their client's project. It's an easy process to become an Authorized Contractor. You simply sign our Contractor Agreement and provide basic licensing documentation.
